The Contracts are in relation to the installation of WIFI infrastructure and the procurement and provision of required infrastructure, system and maintenance services for leading telecommunications operators in Singapore and Thailand respectively.

The Contracts will be completed over a period of approximately three years, beginning from the second quarter of the financial year ending 31 May 2017. The Group is expected to deliver a substantial portion of the current order book within the next 18 months.

The Contracts are not expected to have any material impact on the earnings per share and net tangible assets per share of the Group for the current financial year ending 31 May 2017.
