**1. INTRODUCTION**

The board of directors (the “**Board**” or the “**Directors**”) of Yinda Infocomm Limited (the “**Company**”, together with the subsidiaries, the “**Group**”) refers to the announcement dated 14 May 2021 in relation to the Proposed Equity Investment and the Proposed Conversion (the “**Previous Announcement**”). - 2.2. As at the date of this announcement, the parties are actively involved in fulfilling the remaining conditions precedent to facilitate closing of the Proposed Transactions.
