- Vesting period of Awards : Tranche A : The Awards vest on a straight-line monthly basis as follows:  
(a) 1 October 2025 to 31 August 2026:  
1,041,667 ordinary shares per month.  
(b) 1 September 2026 to 30 September 2026:  
1,041,663 ordinary shares.
- Notwithstanding the Vesting Period, ordinary shares shall be delivered on 30 April 2026 and 30 October 2026.
- Tranche B : Based on the Performance Conditions within the Performance Period.
- Notwithstanding the Vesting Period, ordinary shares shall be delivered on 30 April 2026, 30 October 2026, 30 April 2027 and 29 October 2027.
